## 1 Introduction

- 1.1.1 The Rights of Way Plans (the Plans), listed in Table 1.1, relate to an application made by Anglian Water Services Limited (the “Applicant”) under section 37 of the Planning Act 2008 (the “2008 Act”) for a Development Consent Order (DCO) for the Cambridge Waste Water Treatment Plant Relocation Project.
- 1.1.2 The Plans are included in the DCO application in compliance with Regulation 5(2)(k) of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 (the “2009 Regulations”), which require:
- “5(2) The application must be accompanied by—*
- (k) where applicable, a plan identifying any new or altered means of access, stopping up of streets or roads or any diversions, extinguishments or creation of rights of way or public rights of navigation;”*
- 1.1.3 For ease of cross referencing, the drawing sheets been provided with the same sheet layout, including Inset Plans and even where a particular sheet might not be relevant to a set of plans, for the following application documents: General Arrangement Plans (Application Document Reference 4.2), Works Plans (Application Document Reference 4.3), Rights of Way Plans (Application Document Reference 4.6), Access & Traffic Regulation Order Plans (Application Document Reference 4.7), and Hedgerow and Tree Preservation Order Plans (Application Document Reference 4.8).
- 1.1.4 As these Plans are part of the application documentation, they should be read alongside and are informed by the other application documentation. In particular, these Plans should be read alongside Schedule 6 (Public Rights of Way) of the Draft Development Consent Order (Application Document Reference 2.1) and the Works Plans (Application Document Reference 4.3).

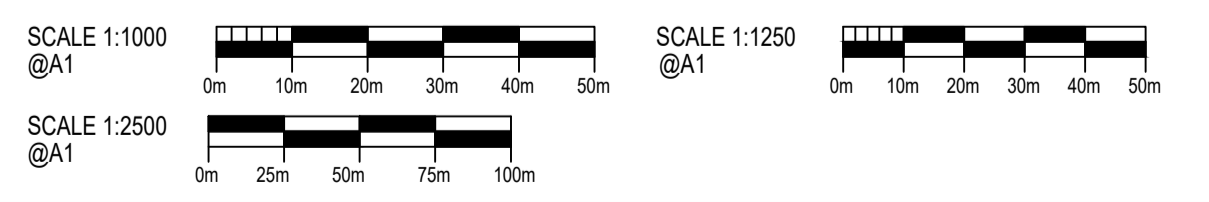

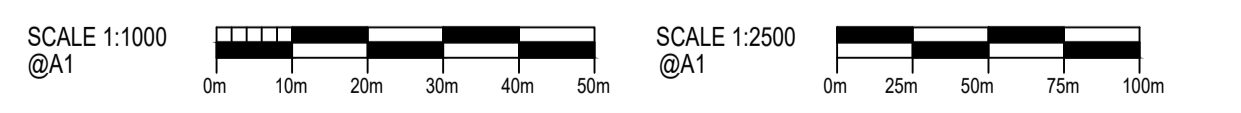
