### ‘I thought I was dying... others need to hear this’

**Exclusive** Long Covid sufferer Adelina tells how she went from being virtually paralysed to riding a bike in 12 days

A Cambridge businesswoman has told how she was preparing to die just days after being struck down by symptoms so serious she could not remember how to do basic tasks and had crushing fatigue that left her almost paralysed.

Adelina Chalmers, 38, pictured, was left exasperated when doctors could not find an explanation for what seemed to be her long Covid symptoms.

“Overnight, it had got really bad and was much worse than Covid itself. I thought I was going to die,” she said.

She was so distraught she began investigating assisted suicide.

But then Adelina, known to clients

As the Geek Whisperer in her role as a consultant to technology and engineering companies, had a chance phone conversation with a doctor friend in Europe about nutritional deficiencies being noticed in long Covid patients.


“That changed everything – and two weeks after seeking a simple treatment at a Cambridge clinic she is back on her feet, making plans to return to work and has even enjoyed her first bike ride.

“If I hadn’t been given the right treatment, I would have ended up disabled,” she said. “I want to tell people about this.”
