Cambridge Waste Water Treatment Plant Relocation Project Change Application: reduction in the Scheme Order Limits

Application Ref: WW010003

Dear Deborah,

I am writing further to our Change Notification Request letter on the 21st of September 2023 and the Examining Authority's (ExA) confirmation dated 26th September that we may submit a Change Application in advance of the Preliminary Meeting on the 17th October.

This letter summarises the Change Application: to make a minor revision to the Scheme Order Limits to reflect a reduction in land take and to submit the relevant updated application documentation. The contents of the Change Application have been informed by the ExA's response to the change notification (Ref: WW010003-000960-NMC) and Figure 2b of Advice 16: Requests to change applications after they have been accepted for examination.

1. Description of the proposed change

The proposed change is a reduction of 2.18ha in the Scheme Order Limits within Works No. 33 (as shown on Works Plan Sheet 10 (Application Document Ref. 4.3.10)) to reduce the extent of the overlap with the consenting boundary of the proposed Waterbeach Railway Station. The total of the Scheme Order Limits has subsequently reduced from 211.07ha to 208.89ha.



The Scheme Order Limits submitted as part of the DCO Application included the flexibility within Works No. 33 for a 100m x 100m construction compound with Works No.34 setting out the other associated construction compounds and temporary storage areas. Now the location of the construction compound has been refined to Plot 070b the works numbers have also been refined with the construction compound now located in the area identified as Works No.34 (as shown in Works Plan Sheet 10 (Application Document Ref 4.3.10)). The proposed construction accesses remain the same (as shown in Access and Traffic Regulation Order Plans Sheet 10 (Application Document Ref 4.7)).

The Proposed Change has no impact on the layout of permanent assets, except for providing further certainty of the route of the Waterbeach Pipeline in this location. The Proposed Change has no impact on how the Proposed Development would be operated.

2. Need for the proposed change

The Applicant can confirm that the statement of need for the proposed change remains as described in the Change Notification request which is confirmed below. The Applicant is submitting a Change Application now as all the necessary information to make the change is readily available and it ensures that the proposed change can be assessed as part of the examination process.

The proposed change has arisen since application submission from our ongoing engagement with SLC Rail, Waterbeach Development Company and other relevant parties. The Applicant is now in receipt of clear and updated plans showing the location of the new Waterbeach Railway Station (planning application approved 9th January 2020) and also confirming the proposed location of the new Waterbeach pumping station. The ExA will note from the Application (Chapter 2: Project Description (Doc 5.2.2)) that the rationale for the current Scheme Order Limits in this area was due to the then unknown location of the new pumping station required for Waterbeach New Town (which does not form part of the DCO Development).

Whilst the pumping station location is not completely final (planning permission is not yet granted), the Applicant understands that the intended location has been further refined following confirmation of the location of the new train station and more detailed designs in respect of the station and associated infrastructure. The refinement of that location by the Waterbeach Development Company means we have been able to review the extent of the Scheme Order limits at the northern end of the Waterbeach pipeline works with a view to reducing the area of land required for the DCO Development including refining the location of the temporary compound.

3. Schedule of Application Documents and Plans

The Application Document Tracker which forms part of the Guide to the Application (Doc 1.3) has been resubmitted as part of the Change Application to indicate the application documents and plans, along with updated revision numbers, which have been updated as part of the revision to the Scheme Order Limits (highlighted in green in the tracker). Three new documents are also being provided as part of the Change

Application, these are the Addendum to the Environmental Statement (Doc 5.1.1), Schedule of Changes to the Book of Reference (Doc 3.4) and Order Limit Change Request Consultation Statement (Doc 6.1.35). These documents are highlighted in orange in the Application Document Tracker.

In order to comply with Point 3 of Figure 2b of Advice Note 16, a Schedule of Changes to Application and Plans has also been provided in Annex A.

4. Infrastructure Planning (Compulsory Acquisition) Regulations 2010

The Applicant considers that the Infrastructure Planning (Compulsory Acquisition) Regulations 2010 are **not** engaged by this change, since the change to the Scheme Order limits is a reduction in the land affected. The proposed change would result in changes to the types of compulsory acquisition and temporary possession sought (such as altering the powers over some land which is currently proposed to be subject to permanent acquisition of rights to powers of temporary possession). There are no interests or areas of land which would be subject to 'higher' powers of acquisition as a result of this change.

5. The Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 (the EIA Regulations)

The Applicant has considered the environmental effects of the proposed change and does not consider that the reduction of the order limits will result in any new or different likely significant environmental effects. The Addendum to the Environmental Statement (Doc 5.1.1) considers the proposed change against of the EIA topics assessed and confirms that there are no changes to the conclusions of the EIA as a result of the proposed change.

The Biodiversity Net Gain (BNG) figures have been revised as a result of the reduction in the Scheme Order Limits, the revised figures are summarised in the Addendum to the Environmental Statement (Doc 5.1.1) with a revised BNG Report provided as part of this Change Application.

6. Consultation

In line with the ExA's response to the Change Notification, the Applicant consulted all those parties with an interest in Plot 69a, as identified within the Book of Reference (Document Reference 3.3), over a period of 14 days which concluded at 11.59pm on the 13th of October 2023. Due to the changes proposed, which also affect plots 070a and 071a, the Applicant also consulted all of the parties with an interest in these plots as identified within the Book of Reference (Doc 3.3). The Applicant consulted 22 identified consultees in total. See Appendix 1 of the Order Limit Change Request Consultation Statement (Document Reference 6.1.35) for a list of consultees consulted.


