Introduction

1. I am writing on behalf of Cambridge City Council [20041390] to submit to the Examining Authority (ExA) matters for Deadline 1 (D1) of the Cambridge Waste Water Treatment Plant Relocation Development Consent Order (DCO) Examination.
2. The matters addressed are set out below.

3. Included within this submission is a revision Local Impact Report for South Cambridgeshire District Council (SCDC). This includes reference to an Addendum Report - Updated odour dispersion modelling for Cambridge Water Recycling Centre December 2020 which is added to Appendix 1: Evidence Library [**Appendix 1, GCSP-20a**]. This has consequential implications for the odour contour shown on Map 1 and for the number of dwellings that lie outside the odour contours in the North East Cambridge Area Action Plan, which changes from 325

dwelling to potentially 1,425 dwellings. The changes are shown by way of track changes and affect paragraphs 6.34, 6.35, Map 1 and paragraph 6.45.

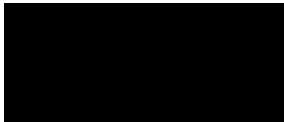
