Please find enclosed submissions from Anglian Water Services Limited (the Applicant), requested by the Examining Authority (ExA) in the Rule 8 Letter (dated 24<sup>th</sup> of October 2023) (PD-007), by Deadline 2 (06<sup>th</sup> December 2023).

## Responses to Examining Authority's First Written Questions (ExQ1)

The Applicant has provided responses to the ExA's first written questions in Document 8.3 'Applicant's Responses to the Examining Authority's Written Questions' at Deadline 1. The Applicant has reviewed the submissions by other interested parties and provided further responses where relevant to do so. These are contained in Document Reference 8.12 'Applicant's Comments on Responses to ExQ1'.

#### **Responses to Local Impact Reports**

The Applicant has commented on the Local Impact Reports (LIRs) submitted at Deadline 1 in Document Reference 8.11. Local Impact Reports were submitted to the ExA by South Cambridgeshire District Council, Cambridge City Council and Cambridgeshire County Council.

#### **Updated Book of Reference**

The Applicant notes that Annex B of the Rule 8 Letter [**PD-007**] sets out that when the Applicant becomes aware that there has been a change in ownership, or a new interest in relevant land they should make the relevant person aware that they can make a request to the ExA to become an Interested Party under section 102A of the Planning Act 2008 by completing the form available on the Project Webpage. It also sets out that an updated Book of Reference should include confirmation that relevant persons have been informed of their rights under section 102A.

The Applicant has not been made aware of any new persons with an interest in the relevant land and therefore no update to the Book of Reference since the submission at Deadline 1 is necessary. The Applicant will be provide an update, if relevant, at Deadline 3.

## **Compulsory Acquisition and Statutory Undertakers Schedules**

As set out in Annex B of the Rule 8 Letter [**PD-007**] the Applicant has provided at Deadline 2 an updated Compulsory Acquisition (CA) Schedule (App Doc Ref 3.5) and Statutory Undertakers Schedule (App Doc Ref 3.6).

#### **Updated dDCO & Updated Explanatory Memorandum**

As discussed during Issue Specific Hearing 1, and pursuant to the Rule 8 Letter [**PD-007**], the Applicant will be providing an updated dDCO and Explanatory Memorandum at Deadline 3.

# **Updated Proposed ASI Itinerary**

The Applicant has submitted an updated ASI itinerary to reflect minor revisions to the Health & Safety information, welfare facilities, timings and maps.

#### **Deadline 02 Examination Document Submissions**

To assist the ExA and Interested Parties in navigating the latest submissions and to highlight where documents have either been superseded or where new documents have been provided, the Applicant has updated its Guide to the Application (App Doc Ref 1.3). Details of the documents submitted as part of Deadline 2 have been provided below along with the reason for the update. The Applicant also notes that the 'Outline Water Quality Monitoring Plan' (Document Reference 5.4.20.13) was also referred to as the Outline Water Quality Management Plan. The correct title is the former and this has been corrected in the updated document submitted at Deadline 2.

The Applicant has also undertaken a review of the Mitigation Tracker, (Document Reference 5.4.2.6, AS-055) and proposes to present an update to the Issue Specific Hearings on Environmental Matters in January and will submit an updated tracker at Deadline 4, 22 January.
