# Landscape, Ecological and Recreational Management Plan (LERMP)

# Relevant to items 5. Ecology, & 8. Landscape and visual/design

As covered in 7.14.8 SoCG [REP3-046] Natural England would like to see a more strategic landscape scale approach, but otherwise supports the habitat creation and enhancement measures set out in the LERMP, and welcomes the commitment to maintain BNG habitats for a minimum of 30 years.

Regarding recreational impacts on Stow-cum-Quy SSSI, as stated under 'Visitor Pressure' in the SoCG, the Applicant has agreed to convene a meeting to progress this matter in January (currently being arranged).
