Sphere25 write on behalf of Sky Telecommunications Services Limited (STSL) in relation to the Development Consent Order submitted by Anglian Water following the publication of the Examining Authority's (ExA) Second Questions on 31st January 2024.

STSL made representations on 17th November 2023 relating to the Compulsory Acquisition Schedule, Land plans, Book of Reference and the Draft Development Consent Order.

Question 8.8 of the ExA's Second Questions directed to Statutory Undertakers states that:

"Please review the Applicant's D4 submissions and identify any outstanding key concerns or impediments with regard to reaching agreement with the Applicant on CA / TP matters and protective provisions, if necessary. Please also clarify whether you are confident of reaching agreement with the Applicant before the close of the Examination, and if not, any implications for this".

We have reviewed the following documents of relevance to STSL:

- WW010003-001463-8.3 Response to ExA's ExQ1
- WW010003-002000-3.5 Compulsory Acquisition Schedule (Tracked)
- WW010003-00921-2.4 DCO Changes Tracker (tracked)
- WW010003-001997-3.4 Schedule of changes to the Book of Reference
- WW010003-001923-3.6 Statutory Undertakers Progress Schedule (Tracked)

We note the responses to our representation made on the 17th November 2023 within document WW010003-001463-8.3 and acknowledge the changes made to the Compulsory Acquisition Schedule (*document reference WW010003-002000-3.5*) to include all land of relevance to STSL. We also welcome the amendments made to the protective provisions of part 8 of the Draft DCO as set out in the DCO changes tracker (*document reference WW010003-001921-2.4*)

STSL confirm that negotiations are ongoing between Anglian Water and its team to agree the necessary rights for telecommunications equipment cabins, mast, cables and ancillary

infrastructure to ensure that the Sky network will remain operational during the course of relocation and decommissioning.

The Statutory Undertaker Progress Schedule (*document reference WW010003-001923-3.6*) notes that negotiations are to be concluded by Deadline 5 (19th February 2024). Whilst discussions are ongoing and agreement may not be reached by Deadline 5, STSL are hopeful that agreement can be reached by the close of the Examination.
