Final Book of Reference

The Applicant notes that Annex B of the Rule 8 Letter [PD-007] sets out that when the Applicant becomes aware that there has been a change in ownership, or a new interest in relevant land they should make the relevant person aware that they can make a request to the ExA to become an Interested Party under section 102A of the Planning Act 2008 by completing the form available on the Project Webpage. It also sets out that an updated Book of Reference should include confirmation that relevant persons have been informed of their rights under section 102A.

Since Deadline 6, the Applicant has identified 29 new persons with an interest in the relevant land and has updated the Book of Reference (App Doc Ref 3.3) accordingly. The resultant changes to the Book of Reference (App Doc Ref 3.3) are listed in the Schedule of Changes to the Book of Reference (App Doc Ref 3.4). The Applicant can confirm that letters have been sent to those 29 parties (the Applicant has sent 31 new interest letters due to 2 interests having two different correspondence addresses) advising them of their right to apply to the Planning Inspectorate to become an Interested Party under s102A of the Planning Act 2008.

Final Compulsory Acquisition & Statutory Undertakers Schedules

As set out in Annex B of the Rule 8 Letter [PD-007] the Applicant has provided at Deadline 7 the final Compulsory Acquisition (CA) Schedule (App Doc Ref 3.5) and Statutory Undertakers Schedule (App Doc Ref 3.6).

Finalised Statement of Reasons

As set out in Annex B of the Rule 8 Letter [PD-007] the Applicant has provided at Deadline 7 the final Statement of Reasons (App Doc Ref 3.1).

Final dDCO & Explanatory Memorandum

The Applicant has provided finalised and validated copies of the draft Development Consent Order (App Doc Ref 2.1) [Supersedes REP5-003 & REP5-004 (tracked)] in PDF and word, DCO Validation Report (App Doc Ref 2.3) [Supersedes APP-011] and the Explanatory Memorandum (App Doc Ref 2.2) [Supersedes REP5-005 & REP5-006]. As per the Rule 8 letter the Applicant has also provided a finalised Schedule of Changes to the dDCO (App Doc Ref 2.4).

In undertaking its final proof read of the DCO, the Applicant has noticed a minor cross referencing error which it has not been able to correct in time for the Deadline due to the length of time required for the Parliamentary Office to validate the SI. The error is in paragraph 100 of Schedule 15 highlighted below (the number “6” should be deleted) and the Applicant would be grateful if the ExA could include this amendment in the version of the DCO included in its report to the Secretary of State. Should the ExA require an amended validation version the Applicant would be happy to seek this request via the Parliamentary Office for Deadline 8, if the Planning Inspectorate case officer could confirm to the Applicant on Monday 15th April.

Part 6 of Schedule 15:

Cash Deposit

100. —(1) *The undertaker shall prior to the commencement of any of the specified works deposit with the local highway authority the cash deposit as security for the performance by the undertaker of its obligations in this Part of this Schedule provided that if the undertaker—*
(a) carries out, completes and maintains the specified works in accordance with this Part of this Schedule 6; and
(b) makes all payments in respect of damages, indemnity, reimbursement or otherwise which may have become payable by the undertaker under the terms hereof or in respect of any breach, non-observance or non-performance of any of the terms hereof; and
(c) in all other respects duly perform their obligations hereunder.

The Applicant also apologises that one of the documents listed in Schedule 18 is incorrectly noted as being updated in April 2024 and should revert to its previous revision, since it is not submitted as an updated version at Deadline 7. This is the Framework archaeological investigation mitigation strategy (App Doc Ref 5.4.13.8). The Applicant would request that the ExA refers to the version noted in the Deadline 5 DCO for this document (September 2023, Revision 01) in the version of the DCO included in its report to the Secretary of State. As with the above should the ExA require an amended validation version the Applicant would be happy to seek this request via the Parliamentary Office for Deadline 8, if the Planning Inspectorate case officer could confirm to the Applicant on Monday 15th April.

Written summaries of oral submissions made at ISH5

The Applicant has provided a written summary of its oral submissions given at ISH5 (Traffic & Transport Matters) this can be found in the Post Hearing Submission (ISH5) (App Doc Ref 8.32).

Closing submissions

A Closing Submission has been prepared by the Applicant (Document Reference 8.33) as a summary of the substantive points raised throughout the Examination as well as a summation of matters agreed with Interested Parties and outstanding issues. The document is intended to assist the Examining Authority (“ExA”) and the Secretary of State (“SoS”) in their reporting

and decision-making on the application for a Development Consent Order (“DCO”) for the Proposed Development. The Applicant’s full case has been set out in the application documents, the Issue Specific Hearings and other evidence submitted during the course of the Examination.

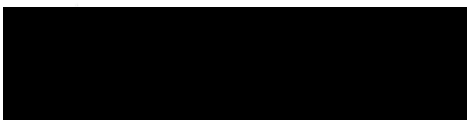
